Athens International Airport (AIA) guarantees to you the best possible price in Athens on products sold at the following participating stores located at the AIA's Shopping Centre. Buy these products at said participating stores located at the AIA's Shopping Centre and if you find a lower price elsewhere in Athens within 30 days of purchase, you will be reimbursed twice the difference as per the terms below:

- The price comparison must be made between 2 identical products (brand, weight, content and supplier reference number). This price comparison must be made between the price paid in one of AIA's Shopping Centre's participating stores as specified herein and the final consumer price, with all taxes included, elsewhere in Athens.
- The "Best Price Guarantee" and the refund commitment are only addressed to private consumers.
- Items on sale, promotional offers, special discounts, lotteries or items purchased with promotional vouchers or items sold below cost are not covered under the "Best Price Guarantee".
- The "Best Price Guarantee" is only valid for products sold by authorized retailers excluding products sold at outlets/stock stores, through mail order catalogues, internet websites or auctions.

The "Best Price Guarantee" is only valid for the following participating stores:

Hellenic Duty Free Shops - Perfumes & Cosmetics, Accessorize, Armani Jeans*, Hugo Boss*, Folli Follie, Sugarfree, Swatch και Juicy Couture.

*For, Armani Jeans and Hugo Boss, the price comparison is valid only for these stores that bear the same trade name (Armani Jeans and Hugo Boss) and only for identical items.

Documents to provide:

- an answer from Athens International Airport S.A. within twenty (20) working days from receiving your request, and
- a refund in Euro from the relevant retailer (via bank deposit in the bank account provided by you as described above) within fourty (40) working days from receiving your request, provided that you are entitled to such a refund as specified herein.
